

Infrared Remote Controllable Paging Horn for SA-Series Self-Amplified Paging System



The Viking model **SA-1H** is a 5 inch paging horn that includes a 1.5 watt power amplifier, an infrared remote control detector, and an integrated digital volume control. The **SA-1H** self amplified paging horn uses a proprietary two wire protocol in which both 40 volts DC power and audio are combined on the same pair of wires. It is designed for direct connection to the Viking Model **SA-25** Self Amplified Paging Control unit, or use the Viking model **SA-X12**

expander/adaptor to connect it to virtually any existing paging system.

The **SA-1H** includes an infrared receiver to accept volume control signals from a Viking Model **SA-IR** remote control. Aim the infrared transmitter at the receiver and press the buttons. The up/down buttons allow users to set the appropriate volume level for each speaker. The speaker provides an audible “beep” feedback tone to let the user gauge the volume level even when there’s no background music (or page) playing at the time.



Installation

- Step 1.** Open the **SA-1H** Receiver cover.
- Step 2.** Connect the 2-wire protocol (40VDC + audio) from a Viking **SA-25** or **SA-X12** to screw terminals 1 & 2.
- Step 3.** Connect the **SA-1H** Paging Horn wires directly to screw terminals 5 & 6.
Note: An optional second 8-ohm paging horn can be added (Viking model 25AE).
- Step 4.** Use screw terminals 3 & 4 to wire any additional Viking **SA-Series** self-amplified speakers.
- Step 5.** Snap the cover back into place.



Operation

Infrared remote control is one of several features that set Viking's self amplified paging system ahead of older legacy Valcom and Bogen systems. The older 4 wire systems required the installer to pull twice as much wire to each speaker, and then have to walk around with a ladder to manually set the volume of each speaker to hopefully the proper level. If the user decides the speakers should have a different volume level, its back up the ladder to adjust more pots.

With the Viking **SA Series** 2 wire self amplified paging system, the installer can connect all the self amplified paging speakers to the same pair of wires, and then simply show the user how to use the **SA-IR** infrared remote control to individually adjust the volume of each speaker.

The convenience of having infrared remote controlled ceiling speakers in an existing paging system can be realized by using the Viking Model **SA-X12** expander/adaptor, which will convert any paging audio source (600 ohm, 4 ohm, 8 ohm, 16 ohm, 25 volt, or 70 volt) to Viking's proprietary **SA Series** 2 wire protocol. Each **SA-X12** can power up to twelve (12) **SA-1S** and/or **SA-1H** self amplified paging speakers.

RETURNING PRODUCT FOR REPAIR

The following procedure is for equipment that needs repair:

1. Customer must contact Viking's Technical Support Department at 715-386-8666 to obtain a Return Authorization (RA) number. The customer **MUST** have a complete description of the problem, with all pertinent information regarding the defect, such as options set, conditions, symptoms, methods to duplicate problem, frequency of failure, etc.
2. Packing: Return equipment in original box or in proper packing so that damage will not occur while in transit. Static sensitive equipment such as a circuit board should be in an anti-static bag, sandwiched between foam and individually boxed. All equipment should be wrapped to avoid packing material lodging in or sticking to the equipment. Include ALL parts of the equipment. C.O.D. or freight collect shipments cannot be accepted. Ship cartons prepaid to:

3. Return shipping address: Be sure to include your return shipping address inside the box. We cannot ship to a PO Box.
4. RA number on carton: In large printing, write the R.A. number on the outside of each carton being returned.

RETURNING PRODUCT FOR EXCHANGE

The following procedure is for equipment that has failed out-of-box (**within 10 days of purchase**):

1. Customer must contact Viking's Technical Support at 715-386-8666 to determine possible causes for the problem. The customer **MUST** be able to step through recommended tests for diagnosis.
2. If the Technical Support Product Specialist determines that the equipment is defective based on the customer's input and troubleshooting, a Return Authorization (R.A.) number will be issued. This number is valid for fourteen (14) calendar days from the date of issue.
3. After obtaining the R.A. number, return the approved equipment to your distributor, referencing the R.A. number. Your distributor will then replace the product over the counter at no charge. The distributor will then return the product to Viking using the same R.A. number.
4. **The distributor will NOT exchange this product without first obtaining the R.A. number from you. If you haven't followed the steps listed in 1, 2 and 3, be aware that you will have to pay a restocking charge.**

TWO YEAR LIMITED WARRANTY

Viking warrants its products to be free from defects in the workmanship or materials, under normal use and service, for a period of two years from the date of purchase from any authorized Viking distributor. If at any time during the warranty period, the product is deemed defective or malfunctions, return the product to Viking Electronics, Inc., 1531 Industrial Street, Hudson, WI., 54016. Customer must contact Viking's Technical Support Department at 715-386-8666 to obtain a Return Authorization (R.A.) number.

This warranty does not cover any damage to the product due to lightning, over voltage, under voltage, accident, misuse, abuse, negligence or any damage caused by use of the product by the purchaser or others. This warranty does not cover non-EWP products that have been exposed to wet or corrosive environments. This warranty does not cover stainless steel surfaces that have not been properly maintained.
